Dear Shareholder,

We would like to inform you that as per SEBI Circular Nos. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/655, dated November 03, 2021 & SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/687 dated December 14, 2021, where all holders of physical securities of the Company are mandatorily required to update (a) PAN (b) Nomination (c) Contact Details (d) Bank Account details (e) Specimen Signature in the records of the Company. Company had already sent letter to that effect in March, 2022 to all the holders of physical securities.

In this regard, SEBI in supersession of above said circulars has further issued circular SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023, regarding mandatory furnishing of PAN, KYC details and Nomination by holders of physical securities and as per which the folios wherein any one of the cited document / details are not available on or after 1st October, 2023, shall be frozen by the Registrar and Transfer Agent (RTA) M/s. Link Intime India Pvt. Ltd. / Company and the security holder(s) whose folio(s) have been frozen shall be eligible to lodge grievance or avail any service request from the RTA only after furnishing the complete documents / details as mentioned above. Frozen folios shall be referred by the RTA / listed Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and / or Prevention of Money Laundering Act, 2002, if they continue to remain frozen as on 31st December, 2025.

We request you to please look into the matter personally and arrange to update your KYC / Nomination with the Company / RTA immediately. We herewith enclose all KYC Forms for your kind reference. You may also download the same from the website of our RTA https://web.linkintime.co.in or Company's website www.plastiblends.com. Please submit your PAN / KYC / Nomination / Bank details etc. to the Company address given above. Please treat the matter as most urgent.
